### Challenge

Collaborating with lawyers in other firms via email proved to be an inefficient way of conducting projects. The team needed a better way to communicate in real-time, with appropriate documentation so that all parties were on the same page.

Veeting Rooms provided the firm with a realtime collaboration platform complete with tools for note-taking, file upload, virtual whiteboard, presentations, and screen sharing. Notes added during meetings became part of the minutes and created a built-in audit trail to improve accountability.

The ability to easily schedule meetings, set agendas, and follow through by turning discussion items into assigned tasks in the firm's project management system has proven very beneficial. Projects are now completed with greater efficiency since communication is clear and productive.
